- 2. The terms of appointment on deputation are as follows:-
 - (i) The terms and conditions of deputation as laid down in the O.M. No. 2/229/91-Estt./(Pay II) dated 05.01.1994, O.M. NO. 6/8/2009-Estt. (Pay II) dated 17th June, 2010 and other instructions issued by Government of India, Ministry of Personnel, Public Grievances and Pension, Department of Personnel & Training from time to time.
 - (ii) The appointment as Assistant Audit Officer shall be at Zonal Office, Patna. However, the official may be transferred to any other EPFO office location on administrative grounds.

 - (vi) In the event of the officer overstaying for any reason whatsoever, he is liable for disciplinary action and other adverse consequences which would include that the period of unauthorized overstay shall not count against service for the purpose of pension and that any increment due during the period of unauthorized overstay shall be deferred with cumulative effect, till the date on which the officer rejoins his parent cadre.
