## **OFFICE ORDER**

Subject: Appointment of Shri S. Muthusamy, Assistant Audit Officer, O/o the Principal Director of Audit, Southern Railway, Park Town, Central Railway, Chennai as Deputy Director (Audit) in Employees' Provident Fund Organization.

On the basis of the recommendation of the Selection Committee constituted for the post of Deputy Director (Audit), Shri S. (Pay II) dated 17<sup>th</sup> June, 2010 and other instructions issued by Government of India, Ministry of Personnel, Public Grievances and Pension, Department of Personnel & Training from time to time.
  - (ii) The appointment as Deputy Director (Audit) shall be at Zonal Office, Bangalore . However, the official may be transferred to any other EPFO office location on administrative grounds.

  - (vi) In the event of the officer overstaying for any reason whatsoever, he is liable for disciplinary action and other adverse consequences which would include that the period of unauthorized overstay shall not count against service for the purpose of pension and that any increment due during the period of unauthorized overstay shall be deferred, with cumulative effect, till the date on which the officer rejoins his parent cadre.

3. If the above terms and conditions are acceptable to Shri S. Muthusamy, Assistant Audit Officer, O/o the Principal Director of Audit, Southern Railway, Park Town, Central Railway, Chennai as Deputy Director (Audit) in Employees Provident Fund Organization in Level-11 of the Pay matrix Pay Band-3 Rs.15600-39100 with Grade Pay Rs.6600/- in Employees' Provident Fund Organization, he may send the written consent through proper channel to Head Office within 10 days of receipt of this offer of appointment.
