OFFICE ORDER

Sub: Promotion to the post of Principal Private Secretary in level 11 in the Pay Matrix (PB-3 of Rs. 15600-39,100/- with Grade Pay of Rs.6600/-pre revised) on regular basis.

On recommendations of the Review Departmental Promotion Committee for the vacancy year 2017-18, the Competent Authority is pleased to approve the appointment of Shri Nityanand Biswal, Private Secretary to the post of Principal Private Secretary in level 11 in the Pay Matrix ((PB-3 of Rs. 15600-39,100/- with Grade Pay of Rs.6600/-pre revised) on regular basis notionally with effect from 29.11.2017 i.e. the date of approval of recommendation of the DPC held on 27.11.2017 by the appointing authority and at par with his junior and for the purpose of monetary benefit w.e.f. the date of assumption of charge at the place of his posting.

2. The promotion of the officer is further subject to the following conditions:

- (i) The date of promotion will be effective from the date of assumption of charge.
- (ii) The officer will be on probation for a period of two years
- (iii) The officer can opt for fixation of his pay within a period of one month from the date he assumes the charge.
- (iv) The seniority of the official will be regulated in the cadre of Principal Private Secretary as per the provisions of EPF Staff (Fixation of Seniority) Regulations, 1989.
- (v) The promotion of the official will be subject to outcome of the Court Cases pending before the Hon'ble CAT/Court in the matter of Ashok Bhatt & Others Vs UOI and Others and Harish Makhija Vs UOI & Others

3. The officer is entitled to TA, DA/Joining Time as admissible under the rules.

4. On promotion the officer is posted to Zonal Office, Bhubaneswar. The controlling authority is requested to forward the joining report submitted by the officer concerned to this office for record.
