OFFER OF APPOINTMENT

Sub: Appointment of Shri Tarun Gupta, Assistant Section Engineer (Civil) as Junior Engineer (Civil) in Employees' Provident Fund Organization.

The Central Provident Fund Commissioner is pleased to approve the selection of Shri Tarun Gupta, Assistant Section Engineer (Civil) as Junior Engineer (Civil) in Employees' Provident Fund Organization in Level-06 of the Pay matrix [Pay Band-2 Rs.9300-34800 with Grade Pay Rs.4200/-(prerevised)] in Employees' Provident Fund Organization on deputation basis initially for a period of three years from the date of joining the post of Junior Engineer (Civil).

- 2. The terms of appointment on deputation are as follows:-
 - (i) The terms and conditions of deputation will be as laid down in the O.M. No. 2/229/91-Estt./(Pay II) dated 05.01.1994, O.M. NO. 6/8/2009-Estt. (Pay II) dated 17th June, 2010 and other instructions issued by Government of India, Ministry of Personnel, Public Grievances and Pension, Department of Personnel & Training from time to time.
 - (ii) The appointment as Junior Engineer (Civil) shall be at EPFO, Regional Office, Ranchi. However, the official may be transferred to any other EPFO office location on administrative grounds.
 - (iii) He will be entitled to TA/DA and joining time as per Rules.
 - (iv) On expiry of three years from the date of joining the post, the deputationist Officer will be deemed to have been relieved on the date of expiry of the deputation period unless the Competent Authority has with requisite approvals, extended the period of deputation in writing, prior to the date of its expiry.
 - (v) In the event of the officer overstaying for any reason whatsoever, he is liable for disciplinary action and other adverse consequences which would include that the period of unauthorized overstay shall not count against service for the purpose of pension and that any increment due during the period of unauthorized overstay shall be deferred with cumulative effect, till the date on which the officer rejoins his parent cadre.
 - (vi) The order of appointment will be issued once the written consent of the concerned officer is received accepting the offer of appointment subject to the above terms and conditions.

3. If the above terms and conditions are acceptable, Shri Tarun Gupta, Assistant Section Engineer (Civil) may send the written consent through proper channel and email alongwith Latest Vigilance Clearance to this office within 10 days of receipt of this offer of appointment.
