Sub: Promotion to the post of Additional Central P.F. Commissioner (ACC) in Level 13A of pay matrix on Ad hoc basis-reg.

On recommendation of Departmental Promotion Committee meeting held on 30.10.2025, for promotion to the post of ACC, the Hon'ble Chairman, CBT, EPF is pleased to approve the appointment of Sh. M.M. Ashraf, RPFC-I to the post of ACC in Level 13A of pay matrix on ad hoc basis for the Panel Year 2026.

2. On ad hoc promotion, the officer shall continue at the present place of posting in-situ till further orders. The ad hoc promotion shall be effective from the date of assumption of charge. The posting order of the officer shall be issued separately.

3. The promotion shall be on ad-hoc basis against the vacancies available on account of sealed cover cases; till the sealed cover cases are finalized or regular vacancies in the grade arise, whichever is earlier. In case any officer whose recommendation is under sealed cover is exonerated and the sealed cover is opened and the officer is found FIT for promotion, he is given priority in promotion, if any and the junior-most officer shall be reverted if no vacancy exists to make place for this officer.

4. The appointment would be without prejudice to the seniority and claim for promotion on regular basis of all other eligible officers and it shall neither confer on him any right to claim for promotion on regular basis, nor seniority.

5. The joining report of the officer as Additional Central P.F. Commissioner on ad hoc basis shall be forwarded to HRM, Head Office through e-mail to rc1.hrm@epfindia.gov.in. Further, the same shall also be updated on HR-Soft Portal.
