Please refer to UPSC Public Notice No. F.1/188(38)/2022-R.IV/SPC-II dated 01.01.2025 wherein you were declared successful as a candidate for the post of Enforcement Officer/ Accounts Officer (EO/AO) in EPFO. Vide EPFO, Head Office Letter No. Recruitment/Exam.12(1)2025/EO-AO/153 dated 22.04.2025, you were issued Provisional Letter of Appointment.

Vide e-mail dated 08.05.2025, you had sought for an extension for appearing in other competitive exams which was acceded to by the competent authority and you were granted extension till 22.06.2025.
