Subject: Cancellation of Appointment to the post of Junior Translation Officer (JTO) (Direct Recruitment) in EPFO - Regarding.

Sir,

On the recommendation of the UPSC, vide Letter No. F.1/85(14)/2023-R.IV/SPC-I dated 22.08.2025, you were declared successful as a candidate for the post of Junior Translation Officer (JTO) in EPFO. Vide EPFO, Head Office Letter No. Recruitment/7(2)2020/Jr.HT/DR/687 dated 16.10.2025, you were issued Provisional Letter of Appointment.

Vide e-mail dated 31.10.2025, you had requested a 6-month extension to be relieved from Bank of India. This office, on the same date, informed you that as per Regulation 20(2) of Bank of India (Officers) Service Regulations, 1979, 3 months' notice is required for getting relieved, and hence, a 3-month extension could be granted, subject to submission of your resignation to Bank of India thereby showing your intention to join EPFO.

Despite this, vide e-mail dated 04.11.2025, you had again sought a 6-month extension, which was rejected, and you were again asked to submit your resignation copy. However, you failed to submit the same to this office.

A Show-Cause Notice dated 19.11.2025 was issued to you directing to submit the resignation copy within 7 days to process your extension request. But you still did not submit the copy of resignation. Since you failed to submit the copy of resignation submitted by you to Bank of India, a last opportunity was provided to you vide this office e-mail dated 26.11.2025 to submit the same by 01.12.2025. You still failed to submit the same or reply to the notice which clearly shows that you are not interested in joining EPFO.

In view of the sufficient time and opportunities already granted to you for submission of your resignation to Bank of India in pursuance to joining EPFO, the Competent Authority has decided to cancel your appointment to the post of Junior Translation Officer in EPFO.

Accordingly, your appointment has been cancelled by the Competent Authority. No further communication in this regard will be entertained.
