Subject: Cancellation of Appointment to the post of Enforcement Officer/ Accounts Officer (EO/AO) (Direct Recruitment) in EPFO - Regarding.

Please refer to UPSC Public Notice No. F.1/188(38)/2022-R.IV/SPC-II dated 01.01.2025 wherein you were declared successful as a candidate for the post of Enforcement Officer/Accounts Officer (EO/AO) in EPFO. Vide EPFO, Head Office Letter No. Recruitment/Exam.12(1)2025/EO-AO/217 dated 22.04.2025, you were issued Provisional Letter of Appointment and requested to join at Regional Office, Nasik within 15 days of issuance of the letter.

Earlier you had stated that you were unable to join at RO, Nasik as your resignation from your previous selection as EO/AO in Coimbatore Zone had not yet been accepted. It came to the notice of this office that your resignation has been accepted by the Competent Authority and you have been duly relieved from RO, Madurai on 17.10.2025. However, you still did not join at RO, Nasik despite getting relieved from RO, Madurai.

In the principle of natural justice, another opportunity was provided to you vide show-cause notice dated 24.11.2025 to join at RO, Nasik within 7 days.

As you still did not report for duty at RO, Nasik, final show-cause notice dated 02.12.2025 was issued to you to join at your allotted place of posting by 12.12.2025. However, as per report received from RO, Nasik, you again failed to join at RO, Nasik.

Your failure to join at RO, Nasik indicates that you are not interested in taking up the appointment in EPFO.

In view of the above, your appointment has been cancelled by the Competent Authority. No further communication in this regard will be entertained.
