Subject: Cancellation of Appointment to the post of Junior Translation Officer (JTO) (Direct Recruitment) in EPFO - Regarding.

Sir,

On the recommendation of the UPSC, vide Letter No. F.1/85(14)/2023-R.IV/SPC-I dated 30.10.2025, you were declared successful as a candidate for the post of Junior Translation Officer (JTO) in EPFO through Waiting List.

Vide e-mail dated 06.11.2025, you were requested to appear before the Addl. Central PF Commissioner, West Bengal for completing document verification formalities. Vide another email dated 06.11.2025, you were requested to submit posting preferences out of the 6 cities (RO Chikkamagaluru, RO Nagercoil, RO Uduppi, RO Tirunelveli, RO Kollam, and RO Kottayam) available for posting in this recruitment cycle. In reply dated 08.11.2025, you requested to post you in Delhi. However vide email dated 11.11.2025, you were informed, *"all the available postings in Delhi and surrounding areas have already been claimed by the candidates higher in rank than you. Removing any of them to place you there would amount to injustice with them. Hence, your request cannot be acceded to. You are requested to submit your preferences to the options submitted to you vide this office email dated 06.11.2025. In case you are not interested in joining EPFO, please submit your refusal so that another candidate from Waiting List could be given the opportunity to join EPFO. Please submit your reply within 3 days"*.

As no response was received from you, a Show-Cause Notice dated 19.11.2025 was issued to you by this office to give the preferences for the specified six offices.

However, vide e-mail dated 25.11.2025, you instead gave preferences for some other Zonal Offices (Zonal ACC Office, Delhi, Zonal ACC Office, Uttar Pradesh, Zonal ACC Office, Haryana, Zonal ACC Office, Punjab & Himachal Pradesh, Zonal ACC Office, Uttarakhand, Zonal ACC Office, Gujarat) as per your convenience which were not available for this recruitment cycle.

Vide e-mail dated 26.11.2025, you were again replied, *"You have given those preferences which were never offered to you. It is again reiterated that allocation of JTOs has been done in accordance with the principle of merit-cum-preference. Had the offices written by you in the mail, had any present vacancy for this recruitment cycle, it would have been offered to all the candidates of your batch and any candidate higher in rank than you would have taken that place. All the candidates selected by the UPSC for the post of JTO have equal rights and this office cannot ignore the rights of others to give a preferential treatment to anybody. Hence, you are requested for the last time to give your preferences for the above mentioned six offices and get your DV done at the Office of Additional CPFC, West Bengal."*

Despite multiple opportunities, you failed to appear before the Addl. Central PF Commissioner, West Bengal for document verification formalities nor did you submit your preferences.

In the interest of natural justice, vide this office email dated 04.12.2025, you were given last opportunity to appear for document verification at the office of Addl. Central PF Commissioner, West Bengal by 10.12.2025. But as per report received from Zonal Office, West Bengal you have neither appeared for document verification nor any communication received from your side.

In view of the sufficient time and opportunities already granted to you for completion of document verification and submission of preferences, the Competent Authority has decided to cancel your appointment to the post of Junior Translation Officer in EPFO.

Accordingly, your appointment has been cancelled by the Competent Authority. No further communication in this regard will be entertained.
