Subject: Allotment of States to the newly recruited Enforcement Officer/Accounts Officer (Direct Recruitment) in Level-8 in the Pay Matrix as per 7th CPC (Rs. 47,600-1,15,100), Pre-revised PB-2 Rs.9300-34800 (with Grade Pay of Rs.4800/-) in Employees' Provident Fund Organisation - Regarding.

Madam/Sir,

The Union Public Service Commission (UPSC) through its first reserve list has recommended 23 candidates for appointment to the post of Enforcement Officer/Account Officer in EPFO vide recommendation letter no. F.1/188(38)/2022-R-IV/SPC-II dated 11.06.2025.

2. The candidates are hereby allotted to the States as per Annexure-A (attached). The Provisional Appointment Letters of the candidates will be issued by the Head Office in due course on completion of their document verification and medical formalities.

3. The cadre controlling Zonal Offices, where more than one candidate have been allotted shall follow the principle of Merit- cum- Preference in allotting Regional Offices to the candidates assigned to the States, in accordance with Head Office letter no. Recruitment/Exam.12(1)2025/EO-AO/E-989735/411 dated 14.02.2025. Candidates having spouse ground and having PwBD status shall be given preference while allotting them the Regional Offices. The dossiers, email IDs and mobile numbers of the candidates are being forwarded to the concerned ZOs for calling of options for cities from the candidates. The Zonal ACCs are requested to ensure that the candidates are allotted to the ROs in accordance with the proportion of sanctioned strength and availability of EO/AOs in the State/UT.

4. The Provisional Appointment Letters of the candidates will be issued by Head Office after completion of their DV and it will be sent directly to the candidates and to Regional Offices where the candidate will be posted. The concerned ROs where the candidate joins, are requested to send a copy of Joining Order of the EO/AO to Recruitment Division immediately on their joining at email id- dreoao.2022@epfindia.gov.in.

5. Those candidates who are already in Govt./ Semi-Govt./ PSU/ Undertaking of Govt. of India/State etc. are required to submit their proper discharge certificate from their previous employer at the time of joining in EPFO.

6. The concerned Regional Office where the candidate joins, are requested to get the Character and Antecedent Verification done from the concerned District/ Police Authorities in accordance with Head Office Order No. A-12011/12/2024-EPFO-HQ/RC/328 dated 07.11.2024 within 6 months of joining of the candidate. The Caste/PwBD/EWS certificates submitted by the candidate may also be got confirmed from the issuing authority. On receipt of Character and Antecedent Verification report and confirmation of Caste/PwBD/EWS certificates of the candidates, the ROs will send the same to the Head Office for issuance of final Appointment Letters.
