6. The officials shall report to the concerned ZO and subsequently the ZO will post them at the ROs as per the Group C transfer policy. The seniority of the transferred officials will be fixed as per Para 6.3 of the Group 'C' Transfer Policy, 2025.
7. All officials may note that, in case at any given time, if it is found that the information/documents provided by them for transfer are false, the transfer order will also be cancelled and the official shall be liable for disciplinary action.
8. No TA/DA/CTG will be admissible to the transferee being request transfer, however, the leave of any kind due, may be sanctioned.
