5. All officials may note that, in case at any given time, if it is found that the information/documents provided by them for transfer is false, the official shall be liable for disciplinary action and the transfer order will also be cancelled.
6. No TA/DA/CTG will be admissible to the transferee being request transfer, however, the leave of any kind due, may be sanctioned.
