*The period of deputation of Shri Thota Venkata Palguna, who has been working as Auditor on deputation since 08.02.2024, shall be from the date of his joining as AAO till completion of the remaining tenure of his existing deputation.

2. The terms and conditions of appointment on deputation are as follows: -

- i) The terms and conditions of deputation will be governed by O.M. No. 2/229/91-Estt./(Pay II) dated 05.01.1994, O.M. No. 6/8/2009-Estt. (Pay II) dated 17.06.2010 and other instructions / Memorandum issued by Ministry of Personnel, Public Grievances and Pension, Department of Personnel & Training, Government of India from time to time.
 - ii) The order of appointment will be issued once the written consent of the concerned officer is received accepting the offer of appointment subject to the above terms and conditions.
 - iii) S/he will be entitled to TA/DA and joining time as per rules.
 - iv) In case the selected official seeks repatriation before completion of two years on deputation, no Transfer TA/DA will be paid on repatriation. Further, if the official seeks repatriation within one year or less, Transfer TA/DA already paid, if any is also liable to be recovered.
 - v) On expiry of three years from the date of joining the post, the deputationist officer will be deemed to have been relieved on the date of expiry of the deputation period unless the Competent Authority has with requisite approvals, extend the period of deputation in writing, prior to the date of its expiry.
 - vi) In the event of the officer overstaying for any reason whatsoever, he is liable for disciplinary action and other adverse consequences which would include that the period of unauthorized overstay shall not count against service for the purpose of pension and that any increment due during the period of unauthorized overstay shall be deferred with cumulative effect, till the date on which the officer rejoins his parent cadre.
3. If the above terms and conditions are acceptable, the above officials may send written consent through proper channel alongwith latest Vigilance Clearance Certificate to this office within 10 days of the receipt of this offer of appointment.


