2. The terms and conditions of appointment on deputation are as follows:-
  - i) The terms and conditions of deputation will be governed by O.M. No. 2/229/91-Estt./(Pay II) dated 05.01.1994, O.M. No. 6/8/2009-Estt. (Pay II) dated 17.06.2010 and other instructions / Memorandum issued by Ministry of Personnel, Public Grievances and Pension, Department of Personnel & Training, Government of India from time to time.

- ii) The posting of the official(s) as Programmer shall be at **National Data Centre (EPFO), New Delhi**. However, the official(s) may be transferred to any other EPFO office location on administrative grounds.
- iii) The appointment order will be issued once the written consent of the concerned official(s) is received accepting the terms and conditions of offer of appointment subject to clearance from Vigilance/DAR.
- iv) S/he will be entitled to TA/DA and joining time as per rules.
- v) On expiry of three years from the date of joining the post, the deputationist official will be deemed to have been relieved on the date of expiry of the deputation period unless the Competent Authority has with requisite approvals, extend the period of deputation in writing, prior to the date of its expiry.
- vi) In the event of the official overstaying for any reason whatsoever, s/he is liable for disciplinary action and other adverse consequences which would include that the period of unauthorized overstay shall not count against service for the purpose of pension and that any increment due during the period of unauthorized overstay shall be deferred with cumulative effect, till the date on which the officer rejoins his/her parent cadre.


