For the candidates posted in Union Territory of Jammu & Kashmir, the office allocation will be made by Addl. Central P.F. Commissioner (HQ), Zonal Office, Delhi, Uttarakhand, Jammu & Kashmir and Ladakh. Once the order of allocation of ROs is issued by the Zonal Office, the controlling officers will relieve the above officials within 3 days of issue of that order. In case the candidate is from the Waiting List of 2024 Batch SSAs and have not yet joined at his allocated office, he will directly join at the allocated office of UT of Jammu & Kashmir. The dossier, DV report and Medical report of such candidates will be directly forwarded by the concerned RO to the newly allotted Regional Office. Since the reallocation/transfer of the above SSAs has been done on their request, they will not be eligible for TA/DA/Joining Time etc. The seniority of the reallocated/transferred officials shall be regulated in accordance with Para 6.3 of Transfer Policy for Group 'C' cadres in EPFO, 2025.
