On recommendation of Departmental Promotion Committee meeting held on 12.02.2025, for promotion to the post of ACC, the Hon'ble Chairman, CBT, EPF is pleased to approve the appointment of Shri Suraj Sharma, ACC (Adhoc) to the post of Additional Central P.F. Commissioner in Level 13A of pay matrix on regular basis for the Panel Year 2025.

- 2. On regular promotion, the officer shall continue at the present place of posting in-situ till further orders. The regular promotion shall be effective from the date of assumption of charge.
- 3. The seniority of the officers shall be regulated in the cadre of ACC as per the provisions of EPF Staff (Fixation of Seniority) Regulations, 1989.
- 4. Regarding pay fixation, the following DoPT guidelines shall be followed:

"In cases where an ad hoc promotion is followed by regular appointment without break, the option is admissible from the date of initial appointment or promotion to be exercised within one month from the date of such regular appointment"
