Subject – Re-allocation of States for the newly recruited Enforcement Officer/Accounts Officers (Direct Recruitment 2025 batch) in EPFO – reg.

Reference: Circular No. Recruitment/Exam.12(1)2025/EO-AO/699 dated 04.11.2025

Sir/Madam,

Please refer to the circular referenced above wherein it was conveyed that the exercise of re-allocation of states allotted to the Enforcement Officers/Accounts Officers of DR 2025 batch is to be conducted and accordingly, the willingness/unwillingness for consideration for re-allocation was sought from the DR 2025 batch EO/AOs.

2. It is informed that the exercise for re-allocation of States has been carried out in respect of already joined EO/AOs (DR-2025 Batch) who had opted for re-allocation to a higher-preferred State, based on the merit-cum-preference principle. This re-allocation process has also resulted in a change in the posting category of certain EO/AOs who did not opt for re-allocation. Only the posting category has been changed for the candidates at S. No. 3, 6, 7, 12, 14, 20, 22, 29, 44, 45, 47, 48, 49, 50, 55, 63, and 64 without any change in their state. Accordingly, concerned Zonal Offices are requested to place these candidates against the social category mentioned in the Remarks column of Annexure-I while preparing the roster.

3. Accordingly, the list containing the new/same posting state in respect of the DR 2025 batch EO/AOs, whose states have been changed as a result of re-allocation and whose posting category has been changed, is enclosed herewith in Annexure-I (attached). The posting category and state allocation of the remaining EO/AOs whose names does not figure in this order will remain the same as per original allocation Order No. Recruitment/Exam.12(1)2025/EO-AO/487 dated 27.03.2025.

4. Some OBC and EWS candidates have been posted against UR vacancies due to providing higher preference to RAUV candidates. Hence, they will be posted against their original social category in the Roster. By doing so, there may be cases

in some states where OBC and EWS candidates would be in excess than the vacancies advertised against that particular category. These should be adjusted while sending requisition for the next recruitment cycle in accordance with DoP&T Circular No. 36012/72/2009-Estt. (Res.) dated 04.06.2010.

5. Since this re-allocation has been done on request/willingness basis in accordance with the preferences provided by the candidates at the time of Pre-Appointment Formalities, these EO/AOs are not entitled for TA/DA/CTG/Joining Time etc.

6. Since Willingness/Request form in Annexure-A to the circular dated 04.11.2025 has already been given by the above stated candidates, it is mandatory for the candidates to join at their re-allocated states, and no representations for retention in the previously allocated state will be entertained. Any EO/AO failing to comply with this re-allocation order will be liable for departmental action.

7. The EO/AOs who are on temporary posting to the EPFO HQ, would join their re-allocated states/ U.T.s (in case opted for re-allocation) after completion of their temporary posting tenure.

8. The Zonal Offices are requested to allocate Regional Offices to the re-allocated EO/AOs under their jurisdiction on the basis of the guidelines issued vide Para 10) of Head Office Circular No. Recruitment/Exam.12(1)2025/EO-AO/E-989735/411 dated 14.02.2025.

9. The re-allocated EO/AOs whose names are mentioned in the Annexure-I shall be relieved from their present place of posting either on joining of candidates from waiting list or 45 days from issue of this order, whichever is earlier.


