Subject: Reallocation of State/Region for the newly recruited Social Security Assistant (Direct Recruitment) in Level-5 (Rs.29, 200-92, 300) in the Pay Matrix with grade pay Rs.2800/-) in Employees' Provident Fund Organisation -regarding.

Reference: Circular No.A-12011/13/2024-EPFO-HQ/RC/711 dated 24/11/2025

Sir/Madam,

Please refer to the above-mentioned circular, wherein the exercise for reallocation of states, allotted to the SSAs of DR 2024 batch was initiated. As per data received from Zonal Offices, some vacancies have arisen in the 2024 Batch SSAs due to cancellation of appointments as well as resignations within 1 year of joining.

1. In view of the above, the Competent Authority has decided to reallocate these vacant seats to the desirous SSAs of the DR 2024 batch who have opted for reallocation on request basis, based on the preferences for posting submitted by them at the time of filing their online application forms through NTA. Consequently, this reallocation has resulted in changes to the state/region of posting for 105 candidates, as detailed in Annexure-I (attached).
2. The 105 candidates listed in Annexure-I shall be relieved by their respective Zonal/ Regional Offices not later than 31.03.2026. Since this reallocation has been done on request basis in accordance with the preferences provided by candidates during filling of online application form, these SSAs are not entitled for TA/DA/CTG/Joining Time etc.
3. Since Willingness/Request Form in Annexure-C to the circular dated 24/11/2025 has already been given by the above stated 105 candidates, it is mandatory for the candidates to join at their reallocated states/zones, and no representations for retention in the previously allocated states/region will be entertained. Any SSA failing to comply with the above reallocation order will be liable for departmental action.

4. Zonal Offices are requested to allocate Regional Offices under their Jurisdiction on the basis of the guidelines issued vide Head Office Circular No. Recruitment/Exam.12(1)2025/SSA/388 dated 03.01.2025.
5. All pending representations, requests, and references regarding the Allocation/Reallocation of States/Regions for newly recruited Social Security Assistants are disposed off with the issuance of this order.

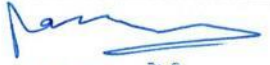

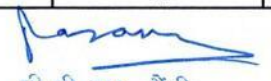
