3. All the grievances shall be submitted by 12-03-2026 to their respective Regional Offices. The Regional Offices after due verification shall compile the requests and forward to Zonal Offices by 16-03-2026 in the below mentioned format. In case of multiple Zone States, Zonal Offices should forward to the Cadre Controlling Authority of the State i.e. ACC (HQ) Office. All the Zonal Offices are to compile all the grievances and forward by 19-03-2026 with copies of the grievances to Head Office at email Id- rc.hrm5@epfindia.gov.in.
