2. Further, the officials whose transfer withdrawal request accepted by the Competent Authority are debarred from seeking request transfer for 5 years. Hence, concerned Zonal offices are requested to not to forward their transfer request to HO until the debarment period.

4. All the officials shall be relieved within 03 days of the issue of this order.

5. The officials shall report to the concerned ZO and later on ZO will post them as per the Group B transfer policy.
6. The transfers are applicable for 6 years only
7. All officials may note that, in case at any given time, if it is found that the information/documents provided by them for transfer is false, the official shall be liable for disciplinary action and the transfer order will also be cancelled.
8. No TA/DA/CTG will be admissible to the transferee being request transfer, however, the leave of any kind due, may be sanctioned.
