2. The officials shall be relieved within 03 days of issue of this order. As these are Mutual Transfers, both the ACC (HQ)/ ACC (Zone) of the Concerned Zones of a "Pair of Mutual Requests" will have to compulsorily relieve both Officials within the given time.
3. In respect of officials who are already serving in the "Transferred to State" on IRT Basis, their relieving order will be issued by their Parent Regional Office based on this order. On receipt of such relieving order, the transferred officials will submit their joining report to the concerned ACC (HQ)/ ACC (Zone) of the "Transferred to State".
4. SSAs of DR 2024 batch who had been reallocated but were not relieved and have not joined their Reallocated State yet, shall be relieved by their Current State itself for reporting to "Transferred to State" directly, under intimation to Reallocated State.
5. The officials are directed to report to the respective ACC (HQ)/ACC Zones of their "Transferred to State" as mentioned against their names. The posting to a specific office (within the State/Region) will be done by concerned ACC (HQ)/ACC Zones, as the case may be. Officials who are already posted in an Office in the "Transferred to State" on IRT basis may be allowed to continue subject to administrative feasibility.
6. The transfer is completely temporary for a period of 06 years from the date of assumption of charge in the "Transferred to State" which is not extendable. After the completion of 06 years, the official will be repatriated automatically under intimation to Head Office.
7. Officials who have already availed the benefit of transfer during the previous year have not been considered, in order to provide a fair opportunity to other eligible officials. The applications of rest of the officials in SSA cadre could not be considered due to various reasons.

8. Officials who withdrew/modified their requests after the last date of submission and prior to convening of the Committee meeting stand debarred from submitting transfer requests for a period of 05 years and the same may be recorded in their service books.
9. No TA/DA/CTG will be admissible to the transferee being request transfer, however, the leave of any kind due, may be sanctioned.
10. The officials may note that, in case at any given time, it is found that the information/documents submitted by them for the transfer are false, the official shall be liable for disciplinary action and the transfer will stand cancelled.
