ORDER

Whereas, Sh. Varun Pratap Singh was recommended by the Union Public Service Commission (UPSC) to the post of Junior Translation Officer (JTO) in Employees' Provident Fund Organisation, Ministry of Labour & Employment, vide recommendation letter no. Letter dated F.1/85(14)/2023-R.IV/SPC-I dated 22.08.2025.

Whereas, on the basis of UPSC recommendation, Sh. Varun Pratap Singh was requested to submit his preferences for posting at some offices of EPFO vide email dated 10.09.2025. Sh. Varun Pratap Singh submitted his preferences vide email dated 18.09.2025.

And whereas, Sh. Varun Pratap Singh was directed by Zonal Office, Delhi & Uttarakhand letter dated 19.09.2025 to report for document verification on 22.09.2025, which he failed to report at.

And whereas, EPFO, Head Office vide email dated 08.10.2025 requested Sh. Varun Pratap Singh to submit his willingness for joining EPFO, which he failed to submit.

And whereas, Zonal Office, Delhi & Uttarakhand vide letter dated 09.10.2025 gave another opportunity to Sh. Varun Pratap Singh to report for document verification on 13.10.2025, which he again failed to report at.

And whereas, EPFO, Head Office vide show cause issued on 10.10.2025 informed the candidate that if he fail to report at Zonal Office, Delhi & Uttarakhand for his Document Verification on 13.10.2025 it will be presumed that he is not interested in joining EPFO and his candidature will be cancelled.

And whereas, Sh. Varun Pratap Singh vide email dated 13.10.2025 has requested to post him in any office near to Delhi NCR. The same cannot be accepted as postings have been decided in accordance with the principle of merit-cum-preference basis.

And whereas, sufficient opportunities have been given to Sh. Varun Pratap Singh to get his DV done, but he has failed to appear for the same.

Now, therefore, the appointment of Sh. Varun Pratap Singh to the post of Junior Translation Officer (JTO) in Employees' Provident Fund Organisation stands cancelled with immediate effect. No further correspondence in this regard will be entertained.
