Dear Candidate,

Please refer to UPSC Letter No. F.I/23(07)/2023-R.IV/SPC-I dated 27.11.2025 wherein you were declared successful as a candidate for the post of Personal Assistant in EPFO. Vide EPFO Head Office Letter No. Recruitment/Exam.12(1)2025/PA/768 dated 12.01.2026 you were issued Provisional Letter of Appointment with a direction to report for duty at the Office of Addl. Central PF Commissioner (ASD), EPFO Head Office within 15 days of issue of provisional appointment letter.

Vide e-mail dated 27.01.2026 you had sought an extension of 3 months for joining at your allocated office. This office on 27.01.2026 had requested you to submit the copy of resignation/technical resignation submitted by you to CGST Delhi Zone to process your request. However, even after lapse of sufficient time, neither did you furnish the resignation copy submitted by you to CGST Delhi Zone nor any other communication was received from your end.

Hence, as a final opportunity, you were issued Show-Cause Notice dated 13.03.2026 to submit the copy of resignation submitted by you to your present department within 7 days' time and to report for duty at ASD, EPFO Head Office on completion of your notice period thereafter. However, you have again failed to comply with the aforesaid instructions. This shows that you are not interested in joining EPFO.

Vide EPFO Head Office Letter No. Recruitment/Exam.12(1)2025/PA/788 dated 29.01.2026 you were issued Provisional Letter of Appointment with a direction to report for duty at the Office of Regional PF Commissioner-I, Regional Office, Chandigarh within 15 days of issue of provisional appointment letter.

Vide e-mail dated 06.02.2026 you had sought an extension of 3 months for joining at your allocated office. This office on 06.02.2026 had requested you to submit the copy of resignation submitted by you to your present employer to process your request.
