2. The terms and conditions of appointment on deputation are as follows:-

- The terms and conditions of deputation will be governed by O.M. No. 2/229/91-Estt./(Pay II) dated 05.01.1994, O.M. No. 6/8/2009-Estt. (Pay II) dated 17.06.2010 and other instructions / Memorandum issued by Ministry of Personnel, Public Grievances and Pension, Department of Personnel & Training, Government of India from time to time.
- The order of appointment will be issued after the written consent of the concerned official is received, accepting the offer of appointment subject to the above terms and conditions.
- Official will be entitled to TA/DA and joining time as per rules.
- In case the selected official seeks repatriation before completion of two years on deputation, no Transfer TA/DA will be paid on repatriation. Further, if the official seeks repatriation within one year or less, Transfer TA/DA already paid, if any is also liable to be recovered.

- v. On expiry of three years from the date of joining the post, the official will be deemed to have been automatically relieved on the date of expiry of the deputation period unless the Competent Authority has, with requisite approvals, extend the period of deputation in writing, prior to the date of its expiry.
- vi. In the event of the official overstaying for any other reason, whatsoever, official shall be liable for disciplinary action and other adverse consequences including that the period of unauthorized overstay shall not count against service for the purpose of pension and that any increment due during the period of unauthorized overstay shall be deferred with cumulative effect, till the date on which the officer rejoins his parent cadre.
3. If the above terms and conditions are accepted by the concerned official, then written consent through proper channel alongwith Latest Vigilance Clearance Certificate must be submitted to this office within **10 working days** of receipt of this offer of appointment.
