5. The Panel will be valid for a period of three years from the date of issue of this empanelment order i.e upto 14.02.2028.

6. The empanelment of Advocates is subject to terms and conditions, duties and responsibilities as laid down in Legal Framework Document of EPFO and as communicated *vide* this Office Notice No. ZO/OR/Empanelment of Adv./239/2024/1261 dated 15.07.2024.
