The practicing advocates who are registered with Bar Council of India/State Bar Council are eligible for empanelment. The qualification, experience, schedule of fees, other terms and conditions and the application format in which the application has to be made, have been prescribed.

The Advocates who are on the existing panel of EPFO shall cease to be on the panel of EPFO after new panel is finalised against this notice. Therefore, they may also apply afresh in response to the notice.

Eligible practicing advocate must submit application in the format prescribed in Annexure"A" and Annexure"B" enclosed herewith, along with all supporting documents in a sealed envelope to:

The eligibility, Qualifications and other terms and conditions for empanelment of advocates is enclosed.

Application for emplanelment at EPFO does not confer any right/assurance whatsoever, to an applicant that he/she will be empanelled on the panel of EPFO. Letters to advocates confirming their empanelment will ne issued by EPFO separately.

GUIDELINES FOR EMPANELMENT OF ADVOCATES

Following guidelines are designed to provide and regulate the manner and procedure for empanelling the advocates to represent and assist EPFO before various courts and for regulating the reterrals of the cases and payment of fee/remuneration. These guidelines shall supersede all existing instructions in this regard, if any, and is subject to change without assigning any reason.

Sefore filling the application form, the punitidates are advised to carefully read and follow the eligibility criteria; instructions and terms & describions for empartelment of Advocates in EPFO mentioned berein below: -

Act, 1952].
- (c) Qualification antiqueperience in promptoting cases in EFFAT
- I) Se enrolled/ registered as an advocate with the State Bar Council
- II) Have a minimum, relevant experience of Ten years of handling Civil, Criminal, Service, Labour, Arbitration matters and other cases with a fair knowledge of labour laws with special reference to Employees' Provident Funds and Miscellaneous Provisions Act, 1952 (E.P.F. and M.P. Act, 1952).

- (ii) The Competent Authority shall have the right in exceptional cases to approve the payment of a higher fee than the fee mentioned in the annexed schedule keeping in view the importance of the matter and the efforts put in by the advocate in a particular case.
- (iii) No retainer les shall be paid to any panel Advocate merely because such advocate has been empanelled.

- b. An applicant advocate willing to be emparated for more than one forum (i.e. for Supreme Court. Deln'High Court of EPFAT) may apply separately for each forum in separate envelope superscribed as mentioned earlier.
- c. Any application received after the last date presimilized in the adjustisement what not be emenalized.
- If his applicant advocate shall be called for interviewinteraction unless he/ she wallslies the eligibility conditions and is shouldstand for the same.

5. Outles of the Empanetied Advocates:

- 1. The Advocate shall not advise any party or accept any case against the EPFO in which he/she has appeared or is likely to be called upon to appear for or advise which is likely to affect or lead to litigation against the EPFO
- Timely appearance of the Counsel to contest the pages for EPFO in the Count is a must. His/her absence in the Count, without any reasonable ground and notice in advance, will not be attented.
- 5. EPFO sends the information to the panel advocates through email regarding entrustment of a case and after receiving the email. It is duty of the panel Advocates to collect the brief/copy of petition along with assignment letter from the sociomed office of EPFO at the earliest.
- EPFO is free to engage any advocate of its bwn choice and an empanelled Advocate shall make no claim trathelatte alone should be entrusted with EPFO's legal matter (s).
- Refusable any advocate to accept any with without any reasonable cause (e.g. on promps of conflict of interest) may exist semi-part of such advocate from the panel, forthwith without waiting for the empanelment period to expire.
- 6. The advocates shall accept the deans and conditions in the emparelment as determined by the EPPD from time to time.
- 7. In order to ensure that mere is effective them; for the cases being conjudied the Advocation on the panel must report the status of the cases after each date of hearing Falluge to submit status report will be a groupe for removal of the name of the lawyer concerned from the panel.

- 13. 30% of the fees payable to the counsel shall be deducted if the certified copy of the judgment is not handed over to the Legal cell of EPFO within three days (excluding the time taken by the Court in preparation of the copy) from the date of judgement.

6. Removal from Panel:

EPFO reserves the right to terminate the empanelment of a Coursel with one month's notice in writing without assigning any reason. The coursel may also resign from the Organisation by serving one month's notice.
