ORDER

Whereas M/s. Bihar Sponge Iron Limited, bearing code: JH/JAM/12557 (hereinafter referred to as the establishment) was granted exemption under clause (a) of sub-section (1) of section 17 of the Employees' Provident Funds and Miscellaneous Provisions Act, 1952 (19 of 1952) (hereinafter referred to as the Act) by the Central Government vide Notification No. S-35015/15/2010-SS-II dated 30.11.2010 w.e.f. 01.05.1992, subject to conditions specified in this regard from time to time;

2. And whereas it has come to the notice to the Central Government that the establishment violated the conditions of Exemption under the provisions of the Act and Employees' Provident Fund Scheme, 1952.

3. Now, therefore, in exercise of the powers conferred by sub-section (7) of section 143 of the Code on Social Security, 2020, the Central Government, being the authority that granted the said exemption to the establishment, hereby cancels the exemption granted to the said establishment with effect from 01.01.2018.

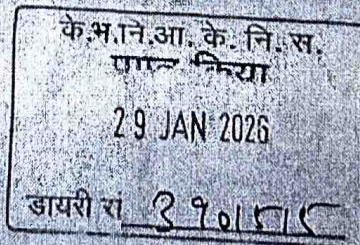
