ORDER

Whereas M/s. Cargill India Private Limited bearing code No. GN/GGN/0027436 in RO Gurugram (East) Region (hereinafter referred to as the establishment) was granted exemption under clause (a) of sub-section (1) of section 17 of the Employees' Provident Funds and Miscellaneous Provisions Act, 1952 (19 of 1952) (hereinafter referred to as the Act) by the Central Government vide Notification No. S-35015/04/2010-SS.II dated Nov 26, 2012 with effect from 01.01.2009, subject to conditions specified in this regard from time to time:

- And whereas the Board of Trustees have desired to surrender the 2. exemption with effect from 01.06.2016 in view of the significant enhancement in the service provided by the Employees' Provident Fund Organization.
