

ORDER

Whereas M/s Ghatge Patil Transport Limited bearing code no. PU/KOL/1603 (hereinafter referred to as the establishment) was granted exemption under clause (a) of sub-section (1) of section 17 of the Employees' Provident Funds and Miscellaneous Provisions Act, 1952 (19 of 1952) (hereinafter referred to as the Act) by the Central Government vide Notification No. S-35015(20)/89-SS-II dated 05.12.1989 subject to conditions specified in this regard from time to time;

- 2. And whereas the EPFO has proposed for cancellation of exemption w.e.f. 01.04.2013 due to violation of Condition no 25 of Appendix A to Para 27AA of EPF Scheme, 1952.
- 3. Now, therefore, in exercise of the powers conferred by sub-section (4) of section 17 of the said Act, the Central Government, being the authority that granted the said exemption to the establishment, hereby cancels the exemption granted to the said establishment with effect from 01.04.2013.
