

**NOTIFICATION**

Whereas M/s. Goa Carbon Ltd. bearing code No. GOA/9962 in Goa Region has applied for surrender of exemption granted by the State of Government under clause (a) of sub-section (1) of section 17 of the Employees Provident Funds and Miscellaneous Provisions Act, 1952 (19 of 1952) (hereinafter referred to as the Act).

2. Whereas a notification bearing No. 25/21/29-IID, dated 10/05/1982 granting exemption to the said establishment under clause (a) of sub-section (1) of section 17 of the said Act w.e.f 10/05/1982 was published in the Gazette of Goa, Daman & Diu, subject to the conditions specified in this regard from time to time.

3. And whereas now it has come to the notice to the State Government that the establishment has desired to surrender its exemption w.e.f. 01/12/2015 as it is facing practical difficulties to operate PF Trust.

4. Now, therefore, in exercise of the powers conferred by sub-section (4) of section 17 of the said Act, the State Government hereby cancels the exemption granted to the said establishment with effect from 01/12/2015.
