ORDER:

In the Government Order first read above, the Government have issued orders for granting exemption under section 17 (1) (a) of the Employees' Provident Fund and Miscellaneous Provisions Act, 1952 (Central Act XIX of 1952) to M/s. Sical logistics Ltd., TN/2589 from the operation of all the provisions of the said Scheme subject to certain conditions specified therein.

2. In the reference second read above, the Additional Central Provident Fund Commissioner (HQ) Exemption, Employees' Provident Fund Organisation, Ministry of Labour and Employment, Government of India, New Delhi has stated that the Central Board of Trustees, Employees' Provident Fund has recommended the acceptance of surrender application of the said establishment for a formal cancellation of exemption under Section 17(4) of the said Act, and has resolved to surrender the exemption granted to the said establishment and requested a formal order in this regard.

3. The Government, after careful consideration, accept the recommendation of the Additional Central Provident Fund Commissioner (HQ) Exemption, Employees' Provident Fund Organisation, Ministry of Labour and Employment, Government of India, New Delhi. Accordingly, in exercise of the powers conferred by sub-section (4) of section 17 of the

Employees' Provident Fund and Miscellaneous Provisions Act, 1952 (Central Act XIX of 1952), the Governor of Tamil Nadu hereby cancel the exemption granted to M/s. Sical logistics Ltd., TN/2589 with effect from 1st May 2013, from the operation of all the provisions of the said Scheme.
