
ORDER

Whereas M/s Timken India Limited, bearing code JH/JAM/12563 (hereinafter referred to as the establishment) was granted exemption under clause (a) of sub-section (1) of section 17 of the Employees' Provident Funds and Miscellaneous Provisions Act, 1952 (19 of 1952) (hereinafter referred to as the Act) by the Central Government vide Notification No. S-35015/102/2002-SS-II dated 28.10.2009. w.e.f. 14.03.1993., subject to conditions specified in this regard from time to time;

2. And whereas the establishment has applied for surrender of exemption w.e.f. 01.04.2018 citing difficulty in maintaining the Trust;

3. And whereas the establishment has started complying as un-exempted establishment w.e.f. 01.04.2018;

3. Now, therefore, in exercise of the powers conferred by sub-section (4) of section 17 of the said Act, the Central Government, being the authority that granted the said exemption to the establishment, hereby cancels the exemption granted to the said establishment with effect from 01.04.2018.
