**ORDER**

Whereas M/s. Virudhunagar Textile Mills Limited bearing code No.TN/293 in Madurai Region (hereinafter referred to as the establishment) was granted exemption under clause (a) of sub-section (1) of section 17 of the Employees' Provident Funds and Miscellaneous Provisions Act, 1952 (19 of 1952) (hereinafter referred to as the Act) by the Central Government vide Notification No. P.F.II-45(23)57 dated 17.10.1957 with effect from 01.12.1955, subject to conditions specified in this regard from time to time;

2. And whereas the Board of Trustees have desired to surrender of exemption with effect from 01.09.2015 due to inability to invest according to the pattern of investment in high yield securities and the establishment has started complying as un-exempted establishment w.e.f. 01.09.2015;

3. Now, therefore, in exercise of the powers conferred by sub-section (4) of section 17 of the said Act, the Central Government, being the authority that granted the said exemption to the establishment, hereby cancels the exemption granted to the said establishment with effect from 01.09.2015.
